# 30 YEARS OF CASA VOLUNTEERS ADVOCATING FOR CHILDREN IN PLATTE & COLFAX COUNTIES

In July, 1992 CASA volunteers began advocating for children in Platte & Colfax county courts under then Judge Gerald E. Rouse. This CASA program was the third CASA program in Nebraska; Sarpy and Dodge counties also had active CASA programs. W. Yvonne Dugan coordinated the program and volunteer advocates included [but were not limited to] Sharon Bahr, Kathy Chadek, Tom DiCostanzo and Cheryl Richardson. Cheryl is a current member of the CASA Connection Board of Directors.

## A LETTER FROM THE EXECUTIVE DIRECTOR - Susan Jarecki

This month's letter is actually from a very dear lady we had as an advocate several years ago. Her name is Charlotte Griffith. Charlotte now lives in Rhode Island, close to her daughter. She recently sent us a donation with the following letter, and I felt this letter and Charlotte's loyalty to CASA needed to be shared. I hope you all enjoy this, as much as I have:

#### But did it help?

Charlotte Griffith 3-15-2022

"I saw a need. I stepped up to help. I gave it my best, but I'm not sure I helped at all!" Familiar feelings? Some of my most satisfying and energizing moments have come when I learned something I did made a difference. Likewise, moments that are the toughest, come when I've felt my efforts may have been wasted or even made things worse. Our family has been blessed with a story that I am going to share here that demonstrates how the effects of interaction with others can be carried for years before acting on it. To me that gives HOPE!

In the spring of 1966, my childhood family doubled in size. My parents married young and had 2 babies before my mother reached the age of 20! My baby sister died shortly after birth and my parents learned they had an RH factor problem and shouldn't have more babies. Mom had a hysterectomy, but she never gave up hope for another child. As my brother, Larry and I headed off for college, they began their search in earnest. They investigated adoption and had several short-term foster kids. Then unexpectedly, they were asked if they would take 4 siblings aged 5 through 9 for a special long-term placement. Mom let me make the call on the decision as it would be my last summer to live at home and I'd be preparing for my wedding. I'd always wished for a little sister, and here was an opportunity to have 2 of them, with 2 new brothers thrown into the mix. The first few days were rather chaotic, but my mother had a gentle strength, and consistent expectations, and gradually life evolved.

The 6 years after the kids came, their biological dad petitioned the court to have his children returned to him. He planned to combine his four kids with his girlfriends three. Mom and dad consulted a lawyer and were advised that biological parents usually got priority and things would be better for them if the kids went "home". As I think back on those years, I find I was focused on my teaching, parenting my children, helping mom and dad downsize, move to care centers and being grandparents. The girls visited mom and dad occasionally, and sometimes our trails crossed. Recently, Larry suggested we get together with our foster siblings. Only one, (the 5-year-old, who is now a grandma herself), Bethany, joined us, and it opened the door.

Neither Larry nor I had any expectation for what would happen next. Bethany called me and Larry to tell us we were both going to receive a letter from her and there would be a check in it along with an explanation. She told us that after they were living on their own, Bethany and her siblings would occasionally go out to our farmhouse when they knew mom and dad would be in church, and fill their cars with gas, or select some cookies that were in the freezer. What bothered Bethany most, though, was that she had lied to mom, telling her she had completed her GED when she had not. As the years went by, she played with the idea of saving money to repay her share and ask mom to forgive her. Then mom died, and she thought she would never be able to do it. When Larry and I reached out to her, she saw a second chance. As Bethany and I talked about how we would use the money, I thought about CASA. When I described what CASA volunteers can do to assist children her face lit up. We brainstormed actions that could have been how this story might have been different if she and her siblings could have had a CASA. No question. We had touched her life! Through writing and reflecting on this I realize it has also made a difference in ours...


